# Section 4 - First Aid Measures

## **General Information:**

## **Section 6 - Accidental Release Measures**

Accidental release: In the event of a major spill, prevent spillage from entering drains or water courses. As a minimum, wear overalls, goggles and gloves. No special recommendations for clothing materials. Eye/face protective equipment should comprise, as a minimum, protective goggles. If there is a significant chance that vapours or mists are likely to build up in the cleanup area, we recommend that you use a respirator. Usually, no respirator is necessary when using this product.
