Section 2 - Hazards Identification

Statement of Hazardous Nature

This product is classified as: Xn, Harmful. N, Dangerous to the environment. Hazardous according to the criteria of SWA.

Not subject to the ADG Code when transported in Australia by Road or Rail in packages 500kg(L) or less; or IBCs (refer to SP AU01). Section 4 - First Aid Measures

General Information:

Section 6 - Accidental Release Measures

No special equipment is usually needed when occasionally handling small quantities. Section 10 - Stability and Reactivity

Reactivity: This product is unlikely to react or decompose under normal storage conditions. However, if you have any doubts, contact the supplier for advice on shelf life properties.
